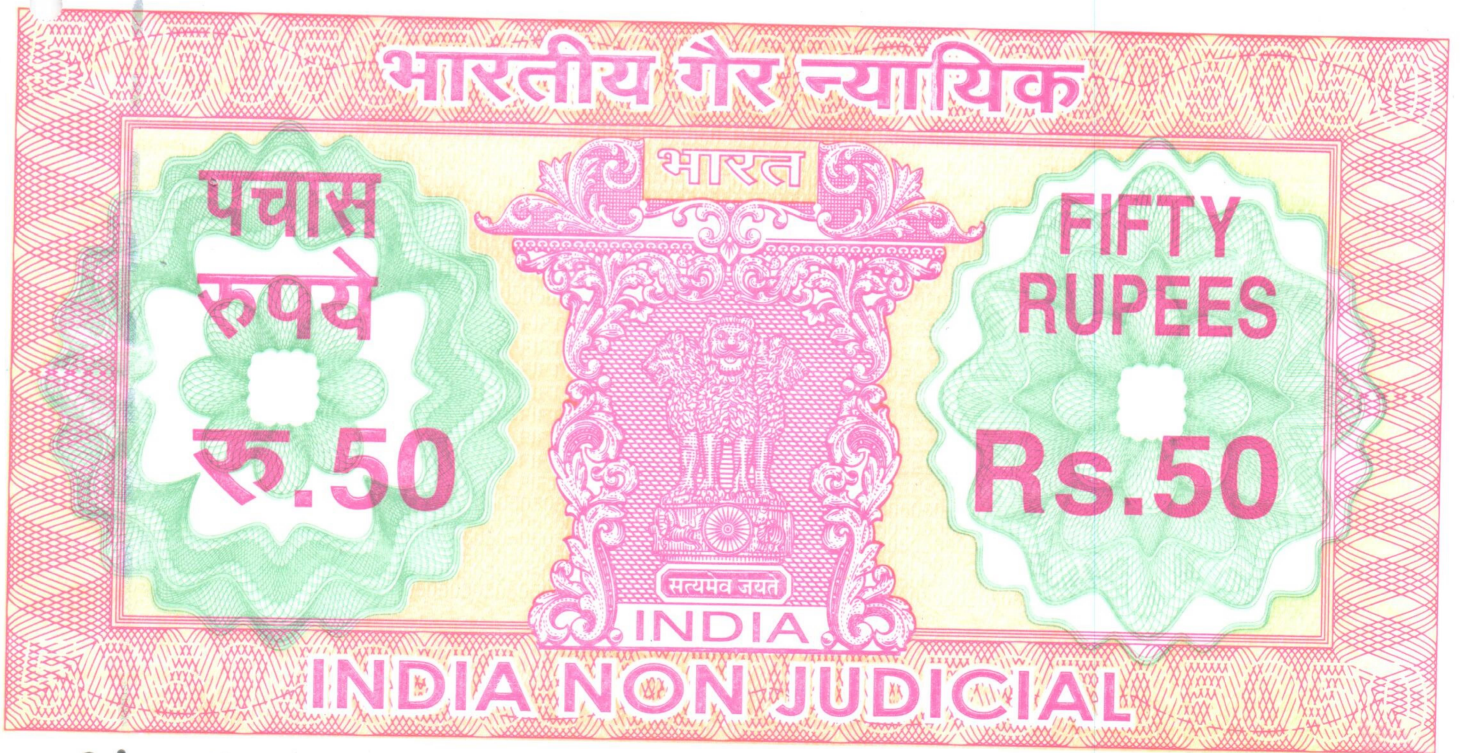
This **DEED OF DECLARATION OF TRUST** executed at Chennai on this 29th day of May 2016 by

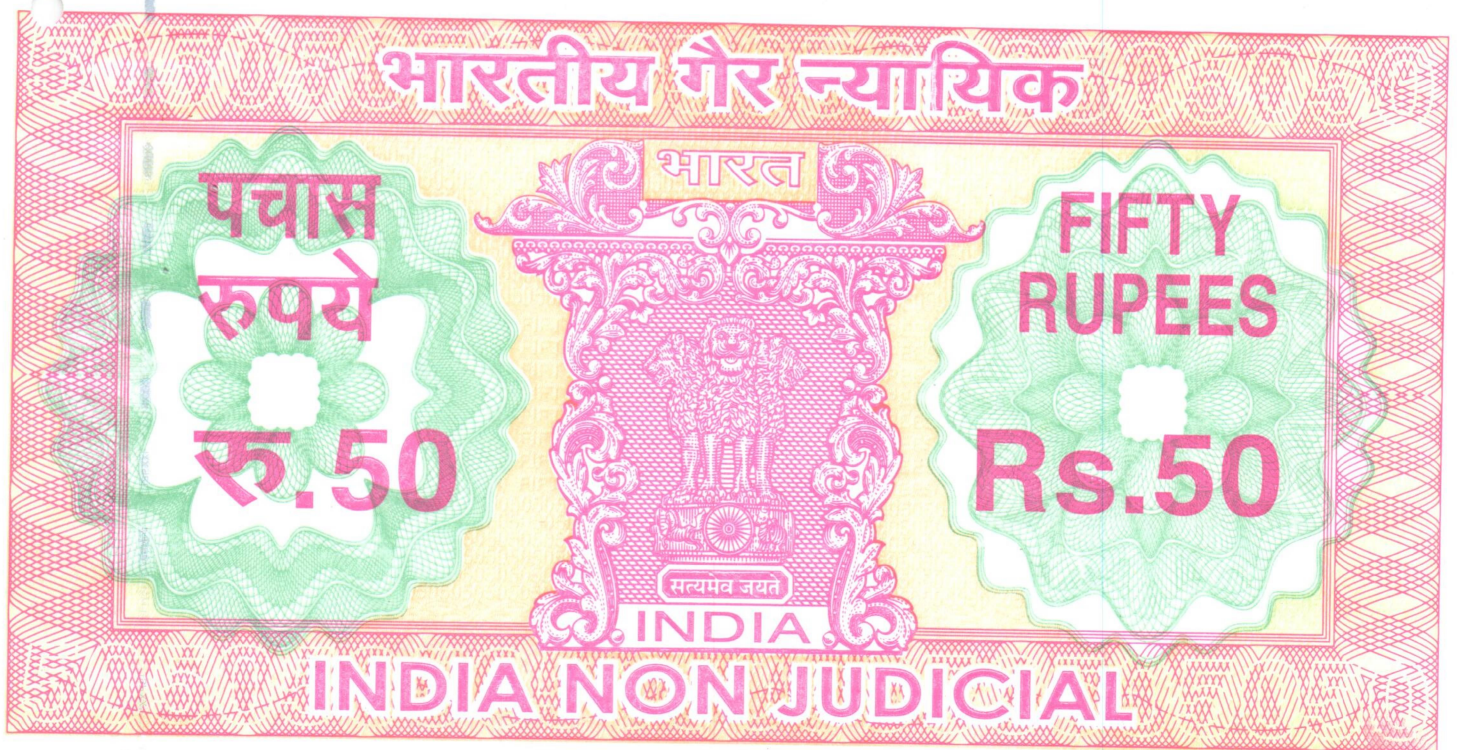
i. EDUCATIONAL:-

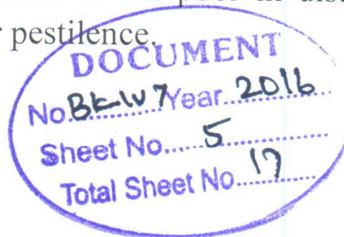

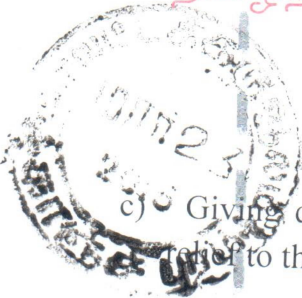

iv. RELIEF TO THE ANIMALS:-

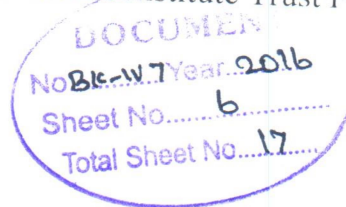
Maintain cows and other animals and to give shelter to them.

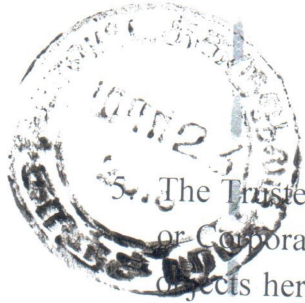

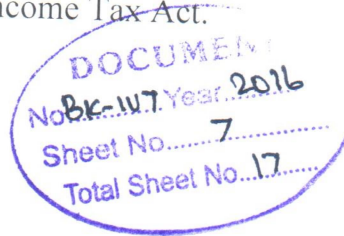

5. 7. It is specifically provided that the investment of the Trust Fund shall be made only in such manner and on such terms as are specifically permitted under the provisions of the Income Tax Act 1961, as amended from time to time and with regard to public charitable trust which are entitled for exemption from Income tax under Income Tax Act. The trustees shall be empowered to vary the investments from time to time in order to comply with the provisions of the Income Tax Act.

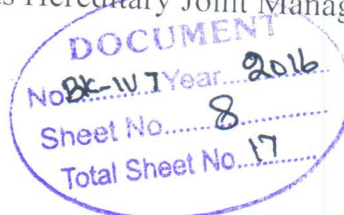

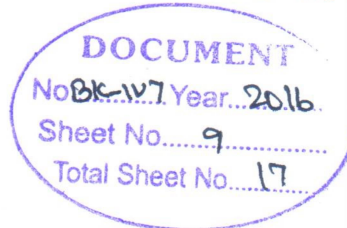

10. The Trustees have power to appoint more trustees in order to carry out the object of the Trust efficiently but in any case maximum number of trustees should not exceed 13.
11. The hereditary trustee has power to nominate his/her successor during his/her life time.
12. In case of death of Hereditary Trustee, his lineal descendant permitted by the Hereditary Trustees in writing or if none is available the wife/husband of the deceased lineal descendant can become a Hereditary Trustee. In case the lineal descendant at the time of death of the trustee is minor, he/she will be entitled to become a Hereditary Trustee when he attains majority subject to other conditions being satisfied.

MANAGEMENT:

- i. The Trust Board shall elect Chairman, Vice-Chairman, Secretary, Joint Secretary and Treasurer who shall manage the Trust and the management shall have power to appoint sub committees and the President and the Secretary are ex-officio members of all the committees and the President shall appoint a chairman for each committee who will look after the work of that committee in consultations with the President and Secretary of the Trust.

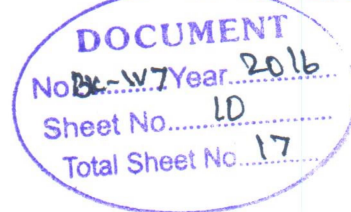

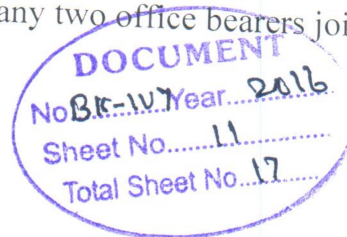
16. ACCOUNTS:-

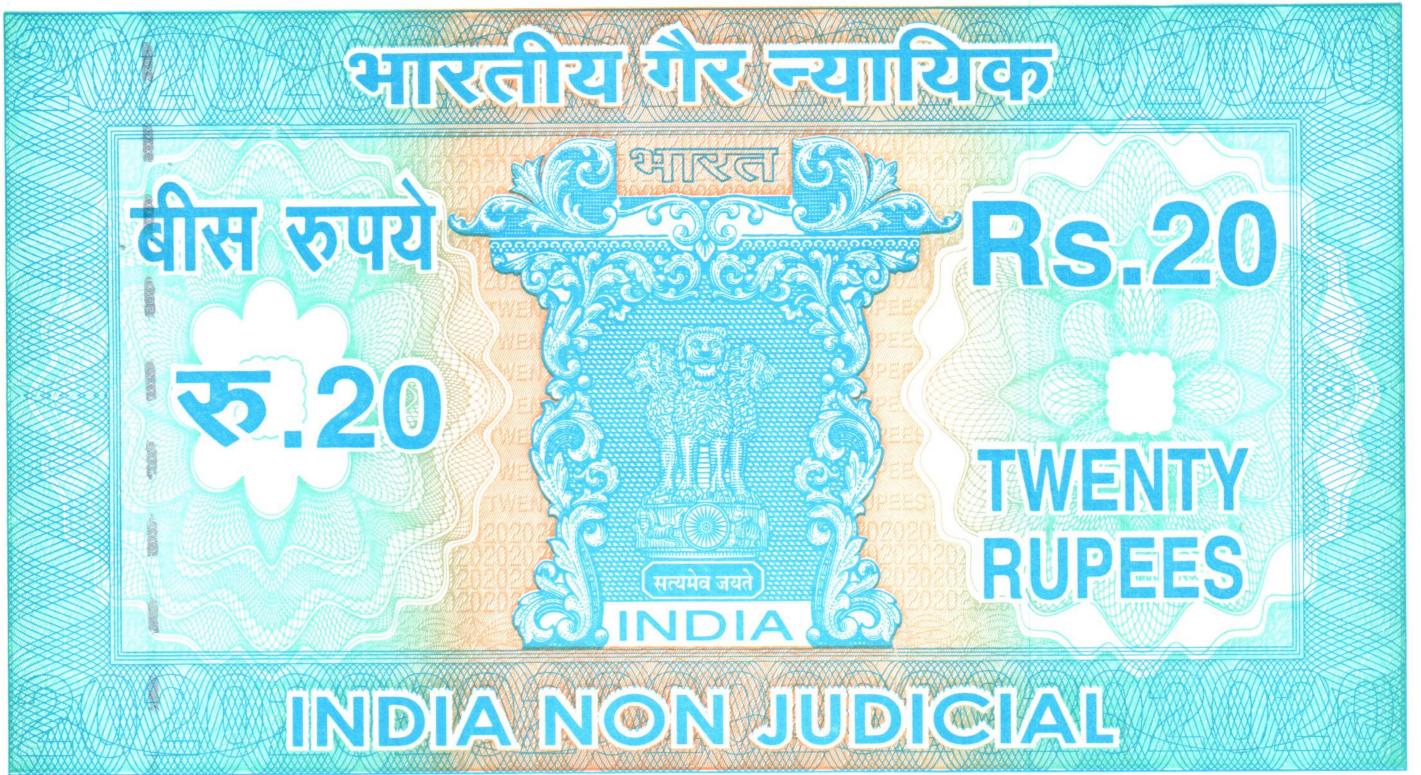
The trust shall maintain regular accounts of income and expenditure. The accounts shall be closed for each year ending on **31st March** of every year and shall be audited by Chartered accountant.
